## Suspended Police Chief's Son Calls for Mayor's Resignation

Justin Ashe, the son of the presently suspended with pay Hoosick Falls Police Chief Robert Ashe, rose to read a letter to the Village Board during the public comment section of their meeting on Tuesday, January 11, in which he accuses Mayor Rob Allen of several improprieties involving both his father, another member of the police force and the officer first placed in charge when Chief Ashe was suspended, as well as misuse of department equipment. He also accused Mayor Allen of not responding to previous correspondence from him dating back to December of 2018.

In the rather lengthy letter, Mr. Ashe is critical of another officer's background, accusing the officer of conducting non-police business on Village time and responding with an officer trainee out of jurisdiction without a 911 Center request or a supervisor's permission. The letter names the officer but *The Eastwick Press* will not at this time, because no official charges against that officer have been lodged.

## A Year Later Bail Reform Still a Hot Topic

Members of the Republican New York State Senate Caucus were joined at the New York State Capitol by representatives of the Law Enforcement Community as well as some NYS Assembly members on Monday, January 10, to express their ongoing displeasure with what was labeled as bail reform, enacted as part of the State's 2019-20 budget process and now law. They criticized this law for taking away critical decision making for judges when it came to setting cash bail for alleged offenders. Specifically the law eliminated cash bail for most misdemeanor and non-violent felonies, including stalking,

> assault without serious injury, burglary, many drug-related offenses as well as some kinds of arson and robbery. The Senate Republicans point to what they call a high rate of criminal recidivism among those released on their own recognizance, and bemoan that judges cannot take into consideration bail for those with long arrest records or other signs they might commit another crime. A report in the New York Times this week says during the first year of bail reform, approxi- Continued on page 11



At the assembly each month, Principal Kent draws names of merit recipients who receive a prize.



























## Community Forest Announcement a Bit of a Surprise

During the public comments section of the Janu- Eastwick Press received inquiries about why all Rescue Plan Act (ARPA) monies, received in July ary 10 regular meeting of the Grafton Town Council, a resident mentioned concerns over an upcoming project by the Rensselaer Plateau Alliance (RPA) on Foster Road that they believe could lead to increased traffic and other potential issues. The RPA's project, involving approximately 300 acres on land situated between Foster Road and Stuffle Street, would be known as the Valentino Family Community Forest. The RPA recently sent out letters to neighboring land owners inviting them to a virtual meeting on Wednesday, January 12, to discuss their plans for the land, which include hiking trails and some special educational programs. Besides the building of some trailheads, there could be parking areas con-

When the speaker asked the Town Council about it, some members indicated they were unaware of the plans and would like to speak to RPA President Jim Bonesteel for more information and clarification. Councilman Pierce Hoyt mentioned inviting him to the January Workshop, but Mr. Bonesteel has indicated he is not available that evening.

The Eastwick Press spoke to Mr. Bonesteel the following day, who admitted they had not sent any information to the Town about the project. He indicated they were concerned about what the neighbors might have to say, hence the planned meeting. Asked about increased traffic, he said it would amount to what you would see if two new homes were built along the road, except when they hold special programs. Then, he says there may be some additional traffic of note. The RPA plans just such a program – a Winter Tracking Workshop – on *Saturday, January 29* at the site.

Once word of the Community Forest broke, The

Board members were not aware of the plans, since the RPA is purchasing the land from Gundrum Logging and Lumber, of which Town Supervisor Ingrid Gundrum is part of the management team, and will impact Town owned roads. The Eastwick Press then posed that question to the Supervisor, who provided us with this answer: "A family member is in the process of selling the subject parcel to the Rensselaer Plateau Alliance. In that a member of my family will realize a pecuniary gain from such sale, it would be inappropriate for me to comment or be involved in any municipal issues involving use of the property by the RPA. I don't believe that I have any disclosure issues under the Ethics Law of the Town.

RPA President Bonesteel was asked if any logging of the site is planned. He indicated that is a possibility within a few years. This raised questions about the impact of heavy logging trucks on these Town roads, not built for such capacity. Mr. Bonesteel indicated the RPA was aware this could be a problem and that it would be addressed at that time.

#### Planning Board in Play as Well

Mr. Bonesteel was asked if the RPA will present their plans to the Grafton Planning Board for review. He indicated they had not planned to do so, but checking with a number of Town officials, it appears an actual site plan filing might be required, with approval, before work could begin at the site.

### Money to the Rescue

The New York State Association of Towns has told Grafton they hope to be releasing some more detailed and perhaps less restrictive instructions from the Federal government as to the use of American

of last year. Many municipalities have been waiting on this guidance before solidifying spending plans. This spending does not need prior Federal approval however any audits of the use of the ARPA monies could mean a municipality might be required to pay the money back, if the use was deemed inappropriate.

The brief meeting was then adjourned in memory of Bernard Cognon, Andre Jones, Wesley Vars, Pete Wescott and Elsie J. Risedorf.

## Mine Expansion To Be Discussed

Following their Thursday, January 6 meeting at which only subdivisions were on the agenda, the full Brunswick Planning Board was informed that the Valente Quarry, currently mining in the Town of Grafton but with land that reaches across the border into Brunswick, is considering crossing that border with their mining operation. To do so would require action by two town boards and the NYS Department of Environmental Conservation. The land located in Brunswick is not zoned for heavy industrial and would require Town Board action to make the change, and the site application would need Planning Board approval. The mining application to DEC would also require a full and very detailed Environmental Assessment Form, on which the Board feels DEC will probably assume lead agency. Unlike the Planning Board, DEC does not typically hold public hearings but sets a definitive period of time in which it would receive written comments on the proposal.

The quarry is located on land entered off NYS Route 2 in Grafton, but adjacent to the Town line. There is also a second quarry located across the road but operated by Troy Sand and Gravel, Not R.J. Valente.

### Approved At Last

For about a year Sean Gallivan has been trying to subdivide property at 159 Deepkill Road into three building lots. This is not the first subdivision of this property, which caused the Planners to seek legal counsel as to whether it should really be a major subdivision, which would have required a lot more paperwork and environmental review. In the end it was determined the major designation was not needed. Dealing with wetlands on the site was also an issue. At their meeting, the Planning Board determined that all the i's had been dotted and the t's crossed, the stars were in alignment in the heavens and there was no real opposition, so the subdivision was granted.

The Board also spent considerable time debating a waiver of subdivision request from Michael Vickers for property located off Kreiger Lane. The original application was filed five years ago, but apparently never completed. The Board and applicant spent more than half an hour debating what was still valid and what wasn't before deciding to adjourn the debate for another gathering.

The Board's next meeting scheduled for Thursday, January 20 at 7 pm.

## Village Awarded \$125,000 BOA Grant

The Department of State has awarded a \$125,000 grant through the New York State Consolidated Funding Application (CFA) to prepare a Brownfield Opportunity Area (BOA) Nomination to the Village of Valley Falls. The old Thompson Mill site is a known brownfield, where contaminants are present in the soil at levels exceeding environmental standards adopted by New York State Department of Environmental Conservation. In addition, this abandoned, burned out mill is a safety hazard to the community. The mill's current dilapidated condition impedes investment and redevelopment in the Village and is an economic and environmental drain. Through the New York Department of State BOA program, this brownfield could be transformed from a liability to a community asset. The program will help build community consensus on the future uses for the area, and establish sustainable goals and objectives for area-wide revitalization. These grant funds, which require local match, will be used to hire professional assistance, which will include an extensive public participation process, existing condition analysis, a market study and development of an implementation strategy.

## Town Council Welcomes the New Year

Council accomplished quite a bit of business during their January 6 organizational meeting, despite some technical issues. Besides several position appointments being approved, including three part-time police officers, the Town Council meeting schedule was finalized and is available on the Town's website.

Fire service contracts with the villages of Castleton-on-Hudson, Nassau and East Schodack were approved. Nassau and Castleton Ambulance contracts and the Schodack Fire Investigation unit were finalized for the 2022 calendar year. South Schodack Fire Company member Roland Ferris was appointed to the Rensselaer County Fire Advisory Board, and fire marshals were approved for the Town Hall, police station and highway garage.

Foreman Brian Brahm will temporarily head the Highway Department, and Foreman Larry Perez will be serving as his assistant until a permanent Superintendent of Highways is hired. The Council also

Supervisor Chuck Peter and the Schodack Town approved library funding for Castleton, East Greenbush and the Nassau Free Library. Supervisor Peter authorized the contract to establish, maintain and operate programs to help veterans at the Peter J. Andrews VFW Post No. 7337. The Council approved the contracts for the Edward C. ## Village and Town Will Be Part of Multi-Site PFOA Study

The New York State Department of Health and the University at Albany School of Public Health have Advisory announced that residents in the Hoosick Falls area (including Petersburgh) are invited to take part in a national Multi-Site PFAS (Per- and Polyfluoroalkyl Substances) Health Study. This by-invitation-only Hoosick effort seeks to recruit eligible adults and families who will then be invited for a health clinic visit for blood and urine testing along with a health evaluation to measure exposure to PFAS. The study will also collect information about the immune response, lipid metabolism, kidney function, thyroid disease, liver disease, glycemic parameters and diabetes. In return, confidential test results will be provided to participants at no cost to them. Recruitment for encourage comparticipants in the Hoosick Falls/Petersburgh area is munity expected to begin in February.

'New York State is collaborating with some of the They also help best researchers in the country to collect data from advise researchers participants with common exposures," said New York State Department of Health Acting Commissioner Dr. Mary T. Bassett. "What we learn by working with these researchers could provide important clues about the complex relationship between PFAS exposures through drinking water and human health

outcomes."

A Community Panel (CAP), made up of unpaid individuals from Falls Petersburgh as well as other communities, is a critical partner in this study. Members relay community questions and concerns and outreach and participation. on study design, outreach and prog-

ress. Members of the local committee plan to tour a proposed site for the clinical visits late in the week of January 10.

Mayor Allen reported several of the locations involved in the Woods Brook Buyout Program have been demolished, with two more at 5 Hall Street and 27 Elm Street slated to come down (weather permitting) in the near future.

#### Help With the Water Bill

The New York State Office of Temporary and Disability Assistance recently announced a Low Income Household Water Assistance Program that deals not only with a person's water bill but any wastewater charges as well. It is done by contracting with water providers for a lower rate. The Trustees voted to authorize the Mayor to submit the agreement.

### Speaking of Water Bills

When water bills go unpaid, the Village at the end of their fiscal year in June sends these bill to Rensselaer County to be relevied on the County tax bill. In the meantime, like with property taxes, the County sends the Village the amount due, while they wait to collect. In June of 2021, this was not allowed via an executive order from former Governor Andrew Cuomo. While the prohibition has been lifted for 2022, the Village is still short money in its Water Department budget. The answer is the issuance of a Revenue Anticipation Note at an interest rate of eight percent. The note will total \$163,684 and is paid back when the County makes the Village whole.

change out of the GAC Filter (used to filter out PFOA from the drinking water), which is expected to begin on January 18.

### **Other Notes**

A long list of rules for the proposed dog park was discussed. Some clarity is still needed such as who enforces the rules and who to call if there is a problem. The Trustees decided they did not want to seem too ruff and placed the matter on their February agenda for more discussion.

The Mayor was authorized to sign an agreement with Spectrum for the installation of internet services at 13 Waterworks Road.

The yearly Village elections are scheduled for Tuesday, March 15. Petitions for the upcoming election need to be received in the Village Office by 3:30 pm on Thursday, February 3. Open seats include three 2-year Trustee seats, a single 1-year Trustee seat and a 4-year Village Justice position.

The Board expects to receive more clarity on the use of their American Rescue Plan Act monies very shortly and discussed holding a public session for feedback on its allowable use. Instead, they decided to discuss the matter more at their February meeting, when hopefully the complete instructions on how they can spend the money will be in hand.

## **Updating Assessment Values**

Assessor Tony Rice told the Hoosick Town Council on Monday evening, January 10, it's time to look at property values again, noting overall property values are up by about 10 percent. He is very quick to emphasize this is not a reassessment, simply an update to keep the Town's equalization rate at 100 percent. This mean homes are assessed at their true value, not a percentage of it.

Mr. Rice said during the last year, many homes in the Town are selling at \$100,000 higher than their assessed value. He also indicated these updates should take place about every five to seven years, with Town Supervisor Mark Surdam noting that when it all shakes out, it has little impact on the actual amount of tax dollars paid by a property owner.

Once again in 2022, the State has ordered that real property tax exemptions in place in 2021 be extended through 2022. This means most exemptions will be automatic, and those receiving the exemptions need not make an appointment with the tax assessor. Mr. Rice says the only exceptions to the no visit policy apply to those seeking a significant exemption change or who have had a major assessment revision.

### **A New Community Forest**

Jim Bonesteel of the Rensselaer Plateau Alliance (RPA) spoke to the Council members by Zoom to announce plans for a new Community Forest encompassing 519 acres of land in the southwestern corner of the Town. The Community Forests lines would also creep over the borders a little into Pittstown and Grafton. Mr. Bonesteel said this would be a working managed forest with limited hunting allowed. The RPA is seeking a grant from the NYS Department of Environmental Conservation to open the forest in spring or summer of 2023. One of the requirements

of this grant is to garner the support of the Town the of Toni Hanselman to aid with the skating sessions. forest is located in. The Council members approved such by motion. This support does not exempt the RPA from any required Town permits.

### **Naturae Is Headed to Court**

The operators of the hemp processing facility on NYS Route 67 in North Hoosick have been served with yet another stop work order by Codes Enforcement Officer Lloyd Moses. Unlike the previous orders which the Town claims have been ignored, Town court is once again open, and a hearing on the order has been set for Thursday, January 27. If the Naturae facility is found to still be in violation, they face some stiff fines and other punitive actions.

The primary complaint by neighbors has been the odor the hemp processing produces.

#### No Luck This Time

The Town's new Highway Superintendent Paul Hoag made his first report that evening. Of primary importance was the Cottrell Road Bridge, which is in need of considerable repairs. Hoosick had applied for funding under the Bridge NY program, which according to Governor Hochul recently handed out more than \$216 million for projects around the State. Almost seems like the Capital Region isn't part of the State, as only one project in the area was funded, and it wasn't the Cottrell Road Bridge. Supervisor Surdam says they will continue to seek State monies. In the meantime the bridge remains open but is down to one lane for the foreseeable future.

#### Time to Hit the Ice

The Weir/Reynolds Skating Rink officially opened on January 8, the date delayed by uncooperative weather.

According to Supervisor Surdam, attendance has been good with 50 people signed up for the learn to skate program. The Council also approved the hiring

His final sentence asks Mayor Allen to do the right thing and step down.



## Justin Mann Sentenced

## White Sentenced for Quadruple Homicide

Rensselaer County District Attorney Mary Pat Donnelly announced on Wednesday, January 12, that James White, 42, of Schenectady was sentenced to life in prison without the possibility of parole for his role in the deaths of two women and two children in Lansingburgh

White was convicted by a trial jury on December 8, 2021 of 9 counts of Murder in the First Degree; 4 counts of Murder in the Second Degree; and single counts of Burglary in the First Degree, Robbery James White in the First Degree and Criminal Posses-

sion of Stolen Property in the Fifth Degree.

"The defendant tried to claim he was not the killer, yet the evidence traces him from Schenectady to Troy and back again with the victim's belongings," said District Attorney Mary Pat Donnelly. "James White and Justin Mann robbed them and then took their lives with an expectation of not being caught. The cowardice of James White displaying no remorse is



troubling." The landscape of the criminal justice system may be changing around us, but our office is committed to justice for the victims of crime in Rensselaer County," added Donnelly.

The Troy Police Department and the York State Police investigated after the victims were first discovered on December 26, 2017. Chief Assistant District Attorney Matt Hauf and Executive Assistant District Attorney Cheryl McDermott presented the case in Rensselaer County Court.

mately 100,000 adults were released under the program, with one-third of those sustaining a new arrest while their initial case was pending. That report says about four percent of these new arrests result in violent felony charges, with about one percent arrested again for a violent felony involving a firearm.

State Senator Daphne Jordan has joined her colleagues in a call for change, stating in a press release Restoring public safety must be job one to ensure that citizens, communities and small businesses are safe from the ongoing wave of violent crime that's threatening the security of all New Yorkers. Repeal of the discovery and bail reforms enacted by the Democrats can help restore the balance of justice and result in a State that's safer and more secure for law-abiding New Yorkers.'

Assemblyman Jake Ashby who also represents most of Rensselaer County issued a statement on Monday in regard to the call for changes. In his press release Mr. Ashby said "Despite only being in effect for a little over a year, the overhaul of our State's Judicial and Cash Bail systems has proven to not only be a tremendous failure but also a driving force in making our communities less safe. It is imperative that we empower our judges and law enforcement officers with the ability to properly carry out the oath they take to protect and serve our community.

The Eastwick Press reached out to Democratic Assemblyman John McDonald, who represents portions of Rensselaer County as well, for his views on the matter. He says bail reform "is a work in progress that needs to be reviewed and tweaked." He agreed that judges need more discretion in when or when not to set bail, but also brought out what he called an inequity in the previous bail laws that favored those with more financial means. He pointed out that in the case of two people charged with the exact same crime and with bail set at the exact same amount, one person with financial means may be released while the second remains locked up. It is this disparity he feels the new bail reform laws start to address and would not like to see them walked back.

While not at the Monday conference, Rensselear County Sheriff Pat Russo said he too wants judges to be able to consider a number of factors when deciding whether to set bail and how much. He told The Eastwick Press he understands the disparity between who may and may not have the financial means to "bail out," but further pointed out those incarcerated have bail hearings, where a number of circumstances can be considered and the amount of bail reduced or eliminated altogether. More importantly to the Sheriff is the question "what about the victims of these crimes? Is it fair for them to have to be concerned or even scared that the alleged perpetrator may be quickly released back on the street to accost them or their property again, or perhaps target another victim?"

Many are waiting to see what Governor Kathy Hochul might have to say on the matter, as she did not address bail reform during her recent "State of the State" address.

#### **Delgado Calls for Lower Medicare Costs for Seniors**

U.S. Representative Antonio Delgado wrote a letter to the Department of Health and Human Services urging them to take action to lower Medicare premiums for seniors. Medicare Part B premiums are set to rise by nearly 15 percent in 2022.

"The COVID-19 pandemic has been devastating

for older Americans, and rising prices have been especially difficult for seniors on a fixed income," said Representative Delgado. "Now is not the time to raise health care costs for seniors. Families and seniors deserve access to the lowest cost prescription drug prices, lower health care costs and access to quality, dependable care.'

## The Life of George Holcomb

### George Buys a Fancy Stove

Saturday October 18, 1851: I went to I had paid him one dollar and 56 cents, Pittsfield with one horse wagon and carried ten bushels fall greenings and sold them to Barker's Grocery at 75 cents per, and I paid 16 dollars to the Troy Stove Store for a Washington airtight improved No. 5 stove with the furniture holloware dinner pot dish kettle spider griddle to roast on, a pan to bake cake on and four pans to bake bread in and a pan to fry meat in and a dipper and one joint pipe fitted onto the stove, and I paid six cents for two ounces of cod liver oil.

Sunday: I this evening walked down to see if Fitzgerald and his boys could work for us tomorrow but could not. Today quite rainy.

Monday: Today I and Geo P. gathered apples and John F. went to Pittsfield with one horse wagon and carried 13 bushels apples and sold them from 50 cts to 95 cts per bushel. He paid 35 cts for ten pound of nails and paid 84 cts for two elbow stove pipe and called to the stove store where I bought my stove on Saturday and got the two pot lids and one hook that was forgotten. Tuesday: Today I and Geo P. gathered apples and drew in two sled loads of the widow Wylie's corn. Today John Coslo called with an order from his brother for his pay for four months at and today I paid him in cash sixteen dollars and 44 cts which pays him up in full.

Thursday: I and my two sons husked corn and stacked the stalks and Anson Knapp worked with us this afternoon and I pay after the rate of seven dollars per month.

Friday: This afternoon I went to Hancock with one horse wagon and carried turnips. I sold 13 bushels in all today to Hancock. Tonight a stranger stayed with us and agreed to work a month for us for seven dollars.

Saturday: This morning the beforementioned stranger quit early, did not go to work. Today I went to Pittsfield with 13 bushels apples and sold them. While I was in Pittsfield I paid to the Troy Stove Store one dollar for 21/4 yards zink to put under our new stove. The evening very dark on the way back, I borrowed a lanthorn of a man that lives in the widow Clark's house near the river, I did not learn his name. Sunday: Towards night I walked to Lebanon and returned the lanthorn I borrowed last evening. This afternoon Geo P. went and fetched Mr. Guy Moffitt to look at his ox that had hard turns to breath, but he could not tell what ailed the ox and did not doctor said ox. four dollars and fifty cents per month, Light snow.
